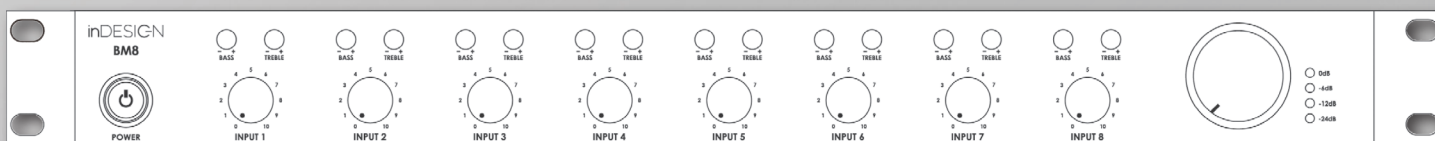

**INTRODUCTION**

The BM8 is a 1RU mono mixer featuring 8 Mic/Line inputs. Microphone inputs 1 & 2 feature 48V phantom power and 2 stage VOX priority override.

With VOX priority enabled Microphones inputs 1 & 2 will mute all other mixer inputs – useful for paging announcements.

The BM8 provides a mono balanced line level output via XLR and a RCA unbalanced line level output (pre master level control).

The mixer features a built in tone module. Tones available are; CHIME; ALERT; BELL; and EVAC; The tones are triggered via dry contact closure connected via external mounted screw terminals.

The mixer is part of inDESIGN's Install Series, which also includes mixer amplifiers, power amplifiers, speakers and playback devices.

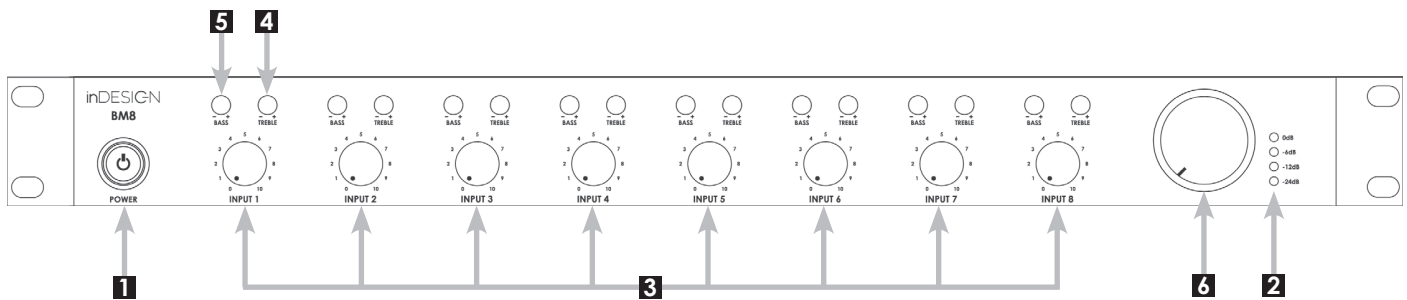

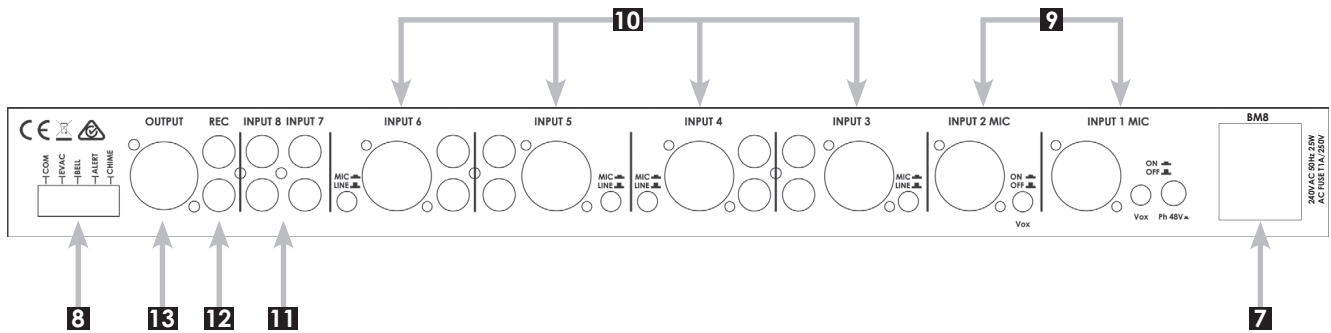

## FRONT PANEL



1. **Power Switch:** Turns mains power on and off.  
The round LED light surrounding the Master Volume control indicates the unit is on/off.
2. **Level Indicator:** To set for optimum working level normal signal should be kept under the 0dB.  
The red +3dB LED will illuminate when signal is excessive.
3. **Input 1 to Input 8:** The selected Microphone or Line input level is controlled via these knobs.
4. **Treble:** Adjust the level to suit the required tone of the output. Increasing the treble may improve intelligibility, decreasing the treble may reduce the onset of high frequency feedback.
5. **Bass:** Adjust the Bass level to suit the required tone of the output. Increasing Bass may make music sound fuller, reducing the Bass in reverberant spaces may improve speech intelligibility.
6. **Master level:** Adjust the overall system volume to suit the environment and use of the system.

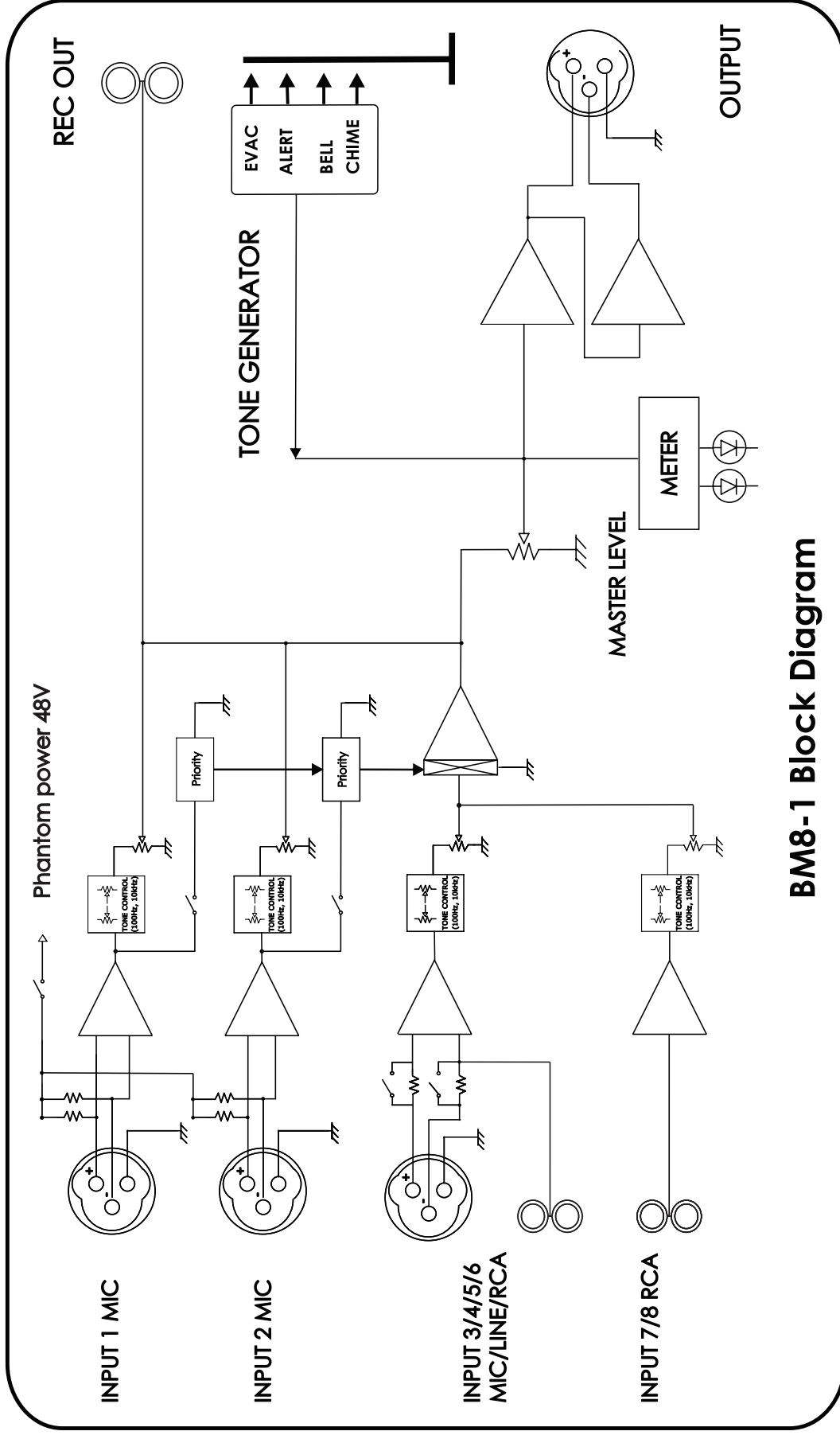

7. **Mains Socket:** The unit is connected to the mains circuit with a standard IEC type power lead. This socket contains a rated slow blow fuse.  
**NOTE: Only use a fuse equal to the marked rating.**
8. **Tone Generator Connections:** There are four alarm triggers; CHIME; ALERT; BELL; EVAC. These are connected via the rear panel Phoenix connector. Each alarm is triggered by a (normally open) switch/relay contact joined between the trigger and the “com” pin.
  - A momentary switch-closure will sound the alarm only ONCE, until it finishes playing out
  - A latched switch-closure will loop the alarm indefinitely, until the switch closure is removed

If 2 (or more) triggers are enabled, each alarm will sound just once and then stop, then the next highest priority alarm will sound. The “EVAC” sound is the highest priority, so if “BELL” and “EVAC” were triggered together, the “BELL” will sound ONCE, then the “EVAC” will continue to sound indefinitely. ANY triggered alarm will override (mute) the audio path of any existing audio on inputs 2-8. Channel 1 audio (which is the priority) is ducked a little, but still audible while the alarm(s) play out.
9. **Input 1-2 Mic:** The microphone input features 48V phantom power for powering Condenser Microphones. Two level priority control VOX with On/Off switch, Input 1 has the highest priority. Microphone 1 input can mute all other inputs.
10. **Inputs 3-6 Mic/Line/RCA:** The input selector switch is used to choose the XLR connector between the Microphone or Line input. The line input can be connected to the Dual RCA inputs. The Dual RCA is internally summed for mono.
11. **Inputs 7 & 8:** These are dual RCA inputs internally summed to Mono.
12. **REC Output:** The REC output provides mono unbalanced line level signal. This output is PRE master level control.
13. **Main Output:** The XLR output provides a balanced line level signal.

## WARRANTY INFORMATION – Terms of Warranty – 5 Years

### Consumer Guarantees

When you purchase a NAS distributed product, you have the peace of mind in knowing that your product is covered by the NAS warranty. The NAS warranty is provided by NAS (National Audio Systems Pty Ltd, ABN 50 085 679 894), 127 Merrindale Drive, Croydon, Victoria 3136, Australia.

The Australian Consumer Law protects consumers by giving them certain guaranteed rights when they buy goods and services. Rights guaranteed under the Australian Consumer Law include;

- The goods are of acceptable quality;
- The goods match their description or any sample or demonstration model;
- The goods are fit for any represented purpose or purpose which the consumer has made known;
- Repairs and spare parts are reasonably available (unless notice has been provided that repairs or spare parts would not be available); and
- The services are carried out with reasonable care and skill and are completed within a reasonable time

These rights are called 'Consumer Guarantees' and apply automatically whenever goods or services are supplied to a consumer. These Consumer Guarantees cannot be refused, changed or limited.

Consumer Guarantees have no set time limit and depending on the price and quality of goods a Consumer may be entitled to a remedy after any manufacturers' or NAS's extended warranty has expired.

The Specific Warranty Table Information outlines the warranty period, warranty type and any specific exclusions for your NAS product. NAS considers the warranty period specified in the Specific Warranty Table to be a reasonable warranty period having regard to the price, design, manufacture and expected use of the product.

### General Warranty ('Warranty')

NAS products come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure or if the goods fail to be of acceptable quality. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and failure does not amount to a major failure. What constitutes a major failure is set out in the Australian Consumer Law.

NAS makes no other express warranties in respect of your NAS product. To make a claim under this Warranty, valid proof of purchase must be presented when the warranty claim is made, along with any other required information. The Warranty offered by NAS is not transferable.

The Warranty will only apply if your NAS product has been installed and used in accordance with NAS's recommendations as noted in the operating instructions.

### Warranty Exclusions

The Warranty does not cover damage caused by;

- Misuse or abuse of the product by You;
- Incorrect operation or not following the operation instructions (as noted in the operating instructions);
- Improper installation;
- Incorrect or improper maintenance or failure to maintain the product;
- Failure to clean or improper cleaning of the product;
- Incorrect voltage or non-authorised electrical connections;
- Adverse external conditions such as incorrect or fluctuations in electrical voltage, thunderstorm activity, acts of God, acts of terrorism, damage caused by vermin, or any other circumstance beyond NAS's control;
- Exposure to excessive heat, moisture or dampness;
- Exposure to abnormally corrosive conditions;
- Alterations or modifications to the product made by You or a third party; or
- Damage as a result of accident, liquid, grit, impact or lack of proper care as indicated in the operating instructions;
- Damage resulting from the use of cleaning solvents such as acetone

The Warranty does not apply if any serial number or appliance plate on the product has been tampered with, removed or defaced.

The Warranty does not apply if the product has been repossessed under any financial agreement.

The Warranty excludes accessories and consumable goods which have ceased working through normal wear and tear such as, but not limited to, batteries, lamps and other parts classifiable as a consumable part.

The Warranty does not cover the loss of any data howsoever caused. You shall be responsible for backing up and protecting data against loss, damage or destruction.

Products presented for repair may be replaced by refurbished products of the same type rather than being repaired. Refurbished parts may be used to repair the products. Replacement of the product or a part does not extend or restart the Warranty Term.

The product will be at the owner's risk whilst in transit to and from all NAS authorised service centres, unless transported by NAS or its authorised representatives.

NAS and its authorised service centres may seek reimbursement of any costs incurred by them when the product is found to be in good working order.

The cost of claiming under this warranty, including return of any product to NAS is to be borne by the consumer.

The Warranty excludes removal or re-installation costs.
